§ 1 Compliance with laws, regulations and guidelines

XINDUX Industrial Solutions GmbH expects all employees to comply with applicable laws and guidelines in their daily work. It also ensures compliance with antitrust laws and laws on competition and fair business conduct and transparent, lawful financial accounting and financial reporting. Corruption is absolutely not tolerated.

§ 2 Human and labor rights

We respect internationally recognized human rights and support their observance. XINDUX Industrial Solutions GmbH strictly rejects any form of child and forced labor. All employees have a right to adequate remuneration; this is recognized by XINDUX Industrial Solutions GmbH.
